#### 1. Be fully aware of the current situation







As for the reform plan on the division of responsibilities that has already been introduced, we need to effectively control the powers of different areas. It will effectively clarify the boundaries of different powers, enhance the standardization, and effectively enhance the enthusiasm of local governments and the central government. At the same time, attention should be paid to clarifying appropriate financial rights on the basis of administrative rights. As mentioned above, local governments bear a large amount of administrative power, but relatively lack of financial power. Therefore, it is necessary to strengthen the input of local governments' financial power, effectively solve the problem of local governments' financial power being ignored, and effectively demarcate the boundary between government financial power and administrative power. In the future development trend, it is necessary to strengthen the overall and systematic development of the reform, optimize the responsibility division scheme, and optimize the local finance[4]. The government should also strengthen the management of government funds, further optimize the efficiency and quality of the use of funds in different areas, and further optimize and improve the structure of government expenditures. If markets





can solve the problem, there is no need for public finances. But if markets cannot do the right thing, public finances will need to be tapped.
